Year one of the model curriculum (2024-2025) includes fall (15 credit hours), winter (14 credit hours), and summer (14 credit hours) sessions for a total of 43 credit hours. Tuition for year one is \$58,136

\*University/Institution fees or costs includes health insurance fees of \$2,520. Students may waive this fee if they can provide proof of personal health insurance coverage. The annual full-time university student services fee is \$600 per semester (\$1,800 per academic year.)

The College maintains a substantial pool of funds for graduate assistantships that range from 10-20 hours per week. Travel stipends are available for students presenting at state, national, and international professional associations. The Office of Residential Life and Student Housing offers assistantships that include housing, a meal plan, a partial tuition waiver, and a monthly stipend. The College has established student scholarship funds for advanced students.
